## SHIPPED SEMEN PROCEDURES

To insure you get semen when your mare needs it and you won't be assessed additional costs, **Please provide your veterinarian with the following information (1-5).**

### **1-SEMEN COLLECTION/SHIPPING DAYS:**

Semen is available any day of the week with proper notification (See #2).

### **2-REQUESTS FOR SHIPMENTS:**

When possible, please notify the Stallion Manager of your mare's reproductive status so that a shipment may be anticipated, then follow up with the final order. Requests will be honored in order of receipt. You must notify the Stallion Manager by phone the day before collection and shipping. For example: Call the farm Sunday evening for semen shipped on Monday for a Tuesday insemination. Same day service is also available with notification. Additional shipping costs vary.

### **3-PAYMENT:**

Payment arrangements must be completed prior to shipment of semen. Payment may be made by check or credit card with credit card authorization on file. A Collection Fee will be billed at the rate of \$225 per collection per mare, plus the cost of shipping.

### **4-CONTAINER RETURN:**

Equitainers must be returned within 5 working days from the date of shipment to avoid additional charges. If it is not received by GSH within 5 working days the Mare Owner will be assessed a \$40 per day rental fee for every day the container is late. We require that you insure Equitainers for \$400 in case of loss or damage to the container. Equitainers not returned will incur a \$400 replacement charge.

### **5-PLEASE NOTIFY:**

Please notify the Stallion Manager of the result of your mare's pregnancy check. We recommend the first check to be 14-16 days after ovulation, also checking for twins. Please feel free to consult with the Stallion Manager regarding any reproductive management issues your mare may have.
